## Applicant Instructions

Thank you for your interest in joining Nashua Fish & Game. Nashua Fish & Game Association membership is open to any person of good character, regardless of race, color, creed, sex or national origin, who is at least eighteen years of age.

The following instructions will help to guide you through the membership application process:

1. Insure that you fully complete the applicant information section and sign both the membership pledge / waiver, and the notice of investigative inquiry.
2. To join the association a senior member of the association must agree to sponsor your membership application. Once you have obtained a sponsor, insure that he/she fully completes the sponsor's section and signs as your sponsor.

Note: If you do not have a sponsor you may attend the monthly Board of Trustee interview meetings, held at our clubhouse on the third Wednesday of each month starting at 6:30PM until 7PM to be interviewed for membership. If you attend a meeting and interview with a trustee, your initiation fee is due at that time.

3. At the time of your orientation the membership governor will collect your initiation fee, first year's membership dues, and a gate key fee, as applicable.
4. Either a valid Concealed Carry Permit/Pistol Permit (CCP) or recent Criminal History Record (CHR) from your home state, or any other state, is required for selection to membership unless the applicant is a person under the age of 18.

## Applicant Fees

**All final applicant membership fees are collected when the applicant attends their New Member Orientation.**

The membership dues at Nashua Fish & Game are \$150.00 per calendar year. By the association's bylaws the new member initiation fee is set equal to the annual dues, \$150.00. The gate credential fee is set as needed to cover the expenses associated with procuring the credentials. This fee is currently \$20.00 and is subject to change in the future.

Initial membership dues are prorated based on the date of the New Member Orientation. Members joining from July to October get a 50% discount (\$75 for first year) and from October to December a 75% discount (\$37.50)

## Initial Membership Fee Calculation

These examples of the initial membership fees are based on Provisional membership dues of \$150.00 per year, with a membership initiation fee equal to the annual dues, and a gate key fee of \$20.00

Example 1: A person attending a January through June New Member Orientation would pay the following:

\$150.00 initiation fee  
\$150.00 year membership dues  
\$20.00 credential fee  
\$320.00 Total

Example 2: A person attending a July through October New Member Orientation would pay the following:

\$75.00 prorated membership dues  
\$150.00 initiation fee  
\$150.00 second year membership dues (optional)  
\$20.00 credential fee  
\$395.00 Total
